

Muskan Foundation put down its roots in 2007, under the leadership of the director and the founder Mrs. Dipti Gandhi, who came across a population of children with Vision Impairment and Additional Disabilities (MDVI) in Mumbai, with no services offered to them. There are very few facilities and services that are provided to children with multiple disabilities. Thus, Muskan is one of the few NGOs working in the field of multiple disabilities.

Muskan provides an array of therapies under one roof to all of its children. The therapies included are Visual Rehabilitation Therapy, Occupational Therapy, Physio Therapy, Speech and Language Therapy and Sensory Integration Therapy. All of the therapists in association with Muskan Foundation are experts in their fields, just like the teachers who are part of the Special Education Unit. The 1:2 teacher-child ratio approach, the use of innovative teaching strategies and techniques are developed to evaluate the child and his/her potential. Based on this the child's IEPs (Individual Evaluation Plan) are created, which monitors the child's progress for the year.

Since, its initiation Muskan has grown from a group of 4 children to 87 students receiving special education and 142 children receiving therapy, across three centers in Mumbai, at Bandra, Goregaon and Lower Parel (Wadia Hospital Unit).









Muskan Foundation is dedicated to provide holistic services to persons with disabilities. In this endeavor, we launched our certificate course in Multiple Disabilities for parents, volunteers and para-professionals. This year, in the process of rehabilitation of children with disabilities its imperative that the parents and para-professionals are well equipped with the knowledge of disability and its impact on the life of the child with disability, his family and the society. This course has the potential to meet these goals.

Sensitizing the society about disability is one of the responsibility that Muskan has taken. We are happy that we have reached out to schools, colleges and corporates in this area. We have also reached the lay persons in public forums on special days like "White Cane Day" and "World Disability Day" to spread awareness about the needs of persons with disability. On the other hand, we also empower parents to take better care of their children and to develop skills and impart knowledge about disability through activities conducted by, Muskan Association for Parent and Professionals (MAPP).

Overall, this year was a successful year with so many individuals and corporate partners involving themselves in the development of Muskan. I acknowledge each and everyone for their support.


